What is the overall deductible?	\$1,000 member/ \$2,000 family Benefits are administered on a Plan Year basis.	Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, they have to meet their own individual <u>deductible</u> until the overall family <u>deductible</u> amount has been met.
Are there services covered before you meet your <u>deductible</u> ?	Yes: <u>emergency room care</u> , prescription drugs, outpatient mental health services, <u>preventive care</u> , <u>provider</u> office visits, routine eye exams, are covered before you meet your <u>deductibles</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But, a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . If you have other family members in this <b><u>plan</u></b> , they have to meet their own <b><u>out-of-pocket limit</u></b> until the overall family <b><u>out-of-pocket limit</u></b> has been met.

### Does this plan meet the Minimum Value Standard? Yes

### Does this plan provide Minimum Essential Coverage? Yes

Minimum Essential Coverage generally includes plans, <u>health insurance</u> available through the <u>Marketplace</u> or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of <u>Minimum Essential Coverage</u>, you may not be eligible for the premium tax credit.
